



## UAB Finances 100% of Emirati Citizens Housing with Repayment Period Up to 25 years

## Sharjah, August 2019:

The United Arab Bank (UAB) has recently signed a memorandum of understanding (MoU) with the Mohammed Bin Rashid Housing Establishment (MBRHE), under which, the UAB would offer housing finance solutions to the UAE nationals who are under the umbrella of Al Yusr program.

Al Yusr program is one of MBRHE's initiatives aiming to provide financial options for UAE national beneficiaries to obtain MBRHE-owned ready properties via partner banks.
